THE BOARD VOTED UNANIMOUSLY TO APPROVE THE PROPOSAL TO PROVIDE A PHASED INCREASE OF THE EXECUTIVE DIRECTOR SALARY OVER A THREE-YEAR PERIOD. A COPY OF EACH DIRECTORS VOTE IS KEPT ON FILE BY THE ARC CFO. ON JUNE 3, 2019 THE BOARD PRESIDENT ISSUED A LETTER TO THE EXECUTIVE DIRECTOR
