THE BOARD VOTED UNANIMOUSLY TO APPROVE THE PROPOSAL TO PROVIDE A PHASED INCREASE OF THE EXECUTIVE DIRECTOR SALARY OVER A THREE-YEAR PERIOD. A COPY OF EACH DIRECTOR'S VOTE IS KEPT ON FILE BY THE ARC CFO. ON JUNE 3, 2019, THE BOARD PRESIDENT ISSUED A LETTER TO THE EXECUTIVE DIRECTOR AND CFO CONFIRMING THE BOARD APPROVAL OF THE PHASED INCREASES. A COPY OF BOTH LETTERS IS ON FILE WITH THE ARC CFO. IN DECEMBER 2020, A NEW EXECUTIVE DIRECTOR WAS APPOINTED. THE FIRST REVIEW OF THE NEW EXECUTIVE DIRECTOR BY THE BOARD IS SCHEDULED IN 2021. A SECOND REVIEW OF THE ARC EXECUTIVE DIRECTOR BY THE BOARD THAT INCLUDED COMPENSATION TOOK PLACE ON DECEMBER 19, 2022. THE THIRD REVIEW FOR THE EXECUTIVE DIRECTOR WAS COMPLETED ON 12/27/23.
